### **PUBLISHING ETHICS AND MISCONDUCT**

#### **Duties and Responsibilities of Author**

**Originality and Plagiarism:** Authors must ensure that their work is original and properly attributed to the original sources when using the work or ideas of others. Plagiarism in any form, including self-plagiarism, is strictly prohibited.

**Data and Results:** Authors should accurately present their research findings and provide sufficient details to allow others to replicate their work, when applicable. Fabrication, falsification, or manipulation of data and results is unethical and unacceptable.

**Authorship:** All individuals who have made substantial contributions to the research should be listed as co-authors. Proper acknowledgment should be given to individuals who have contributed in a meaningful way but do not meet the criteria for authorship.

## الافتتاحية
